# TEXAS STATE BOARD OF PHARMACY

## DISCIPLINARY ACTIONS

### March – May 2015

---

After the Board obtains evidence of alleged violations, a licensee is sent a preliminary notice letter of the Board's intent to institute disciplinary action.

The licensee then has an opportunity to show compliance with the law in an informal conference with the Board staff (Executive Director/ Secretary, Board Legal Counsel, and other staff at the discretion of the Executive Director and Board Legal Counsel). If the licensee cannot show compliance with the law and desires to dispose of any pending allegations, the licensee may consent to the entry of an "Agreed Board Order." The licensee must agree to the terms of the order and the order must be approved by the Board.

It should be noted that while there is agreement on the part of the licensee to the entry of an "Agreed Board Order," there is neither admission nor denial of guilt with respect to any matters that have come to the attention of the Board.

If a licensee, or the Board does not agree to terms of the "Agreed Board Order" or if the licensee does not wish an informal conference, a disciplinary hearing is scheduled before an Administrative Law Judge from the Office of Administrative Hearings. The Administrative Law Judge, after hearing all evidence in the matter will make a recommendation to the Board for action to be taken. The Board then makes a decision in the case, which is documented by the entry of a "Board Order."

On the finding of the existence of grounds for discipline of a licensee, the Board may suspend, revoke, restrict, fine, refuse to issue or renew, probate, reprimand, cancel, or retire a license.

Although every effort is made to assure that the following information is correct, you should contact the Board's office to confirm the accuracy of the listing before making any decision based upon this information. Copies of specific orders may be obtained for a fee, upon written request.

## HIPDB

The Health Insurance Portability and Accountability Act of 1996 established the Healthcare Integrity and Protection Data Bank (HIPDB), a national healthcare fraud and abuse data collection program. In order to implement HIPDB, the U. S. Department of Health and Human Services adopted rules that require all state health licensing agencies to report disciplinary actions imposed on its licensees. The Texas State Board of Pharmacy (TSBP) is required to submit reports to HIPDB regarding all disciplinary actions taken against pharmacists, pharmacies, pharmacist-interns, and pharmacy technicians. After HIPDB receives a report from TSBP, HIPDB will send a copy of the report to the licensee. The licensee will be given the opportunity to respond to the report.

Agreed Temporary Restriction Order accepted by licensee and entered by the Board on 05-26-15: license restricted to prohibit high-risk sterile compounding until licensee meets certain requirements and must develop and implement policies and procedures to ensure that compounding personnel are complying with rules relating to sterile compounding.

Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: license reprimanded and must develop and implement a Continuous Quality Improvement Program (to include peer review) for purposes of preventing and handling dispensing errors.

**CVS/Pharmacy #7198**, Pharmacy License No. 24503, Houston, TX. Alleged violation: dispensing error. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 2-year probation with conditions and must develop and implement a Continuous Quality Improvement Program (to include peer review) for purposes of preventing and handling dispensing errors.

**CVS/Pharmacy #7442**, Pharmacy License No. 24701, Austin, TX. Alleged violation: dispensing error. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: license fined \$1000 and must develop and implement policies and procedures to detect shortages and prevent theft and loss of controlled substances.

**Sheila Beth Dawson**, Pharmacist License No. 31643. Alleged violations: dispensing error and failed to evaluate and identify the clinically significant high dosage while working at Brookshire Pharmacy #74 in Greenville, TX. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 2-year probation with conditions; fined \$1000; and must obtain additional CE.

**Drug Crafters**, Pharmacy License No. 25301, Frisco, TX. Alleged violations: pharmacy shipped prescription drugs into other states without holding a license in those states and dispensed controlled substances pursuant to invalid prescription orders. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 1-year probation with conditions; license fined \$10,000 and must develop and implement policies and procedures for ensuring valid licensure from other state licensing entities.

Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 2-year probation with conditions; fined \$10,000 and must successfully pass the pharmacy law exam.

**Anuli Obianuju Nabo**, Pharmacist License No. 51187. Alleged violations: while working at Walgreens #6857 in Houston, TX, failed to provide verbal patient counseling and allowed a pharmacy technician to perform a duty that may only be performed by a pharmacist, in that the pharmacy technician communicated information about the dispensed drug to the patient. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 2-year probation with conditions and license fined \$1000.

**Joseph Franklin Neely**, Pharmacist License No. 43155. Alleged violations: while working at Wal-Mart Pharmacy #10-420 in Wichita Falls, TX, committed a dispensing error and engaged in fraud, deceit, or misrepresentation in the practice of pharmacy by creating a prescription to account for the dispensing error. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: license reprimanded; fined \$5000; and must obtain additional CE.

Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: license reprimanded; fined \$1500; and must develop and implement a Continuous Quality Improvement Program (to include peer review) for purposes of preventing and handling dispensing errors.

**Walmart Pharmacy #10-473**, Pharmacy License No. 21583, Giddings, TX. Alleged violation: dispensing error. Agreed Board Order accepted by licensee and entered by the Board on 05-05-15: 2-year probation with conditions and must and must develop and implement a Continuous Quality Improvement Program (to include peer review) for purposes of preventing and handling dispensing errors.

**REHABILITATION ORDERS**

Section 564.002 and 564.003 of the Pharmacy Act exempts from the Texas Public Information Act, the records of TSBP concerning pharmacists who have or have had an alcohol or drug dependency or who have developed an incapacity of a nature that prevents a pharmacist from engaging in the practice of pharmacy with reasonable skill, competence, and safety to the public.

Thus, Disciplinary Orders entered as a result of such impairments are confidential. Because of this confidentiality only the number of rehabilitation orders that have been entered by TSBP, will be published; the name of the pharmacist (and any pharmacy that is involved) is not published.

Thirty-seven such orders were entered by the Board from March - May 2015. This number may include the following types of orders:

- (1) new orders entered on pharmacists who have or have had a chemical dependency, or mental or physical impairment;
- (2) subsequent orders on these individuals; and
- (3) orders entered on a pharmacy license as a result of violations or alleged violations by a pharmacist with an impairment.
